RANCH POLICIES

1. All hunters must have a valid Texas hunting license and abide by all Federal and State game laws.
2. All hunters must sign a Release and Indemnification Agreement upon arrival and prior to hunting.
3. Heart-Bar™ Hunting Services reserves the right to utilize any and all photographic and other media material captured during hunter's time on the ranch for advertising purposes.
4. Hunters will abide by all written and oral instructions from the ranch personnel. Any violations of State or Federal game laws or the ranch policies will result in loss of hunting privileges without a refund, and will be reported to the proper authorities.
5. Arrival at the ranch will be 11:00 a.m. on the first day of your hunt and departure will be by 11:00 a.m. on the final day. Daily access will be 1 hour before sunrise until 1 hour after sunset. Ranch personnel will determine the exact times.
6. No moving from your blind or stand between daylight and 9:30 a.m. and 3:30 p.m. and dark. The time between 9:30 a.m. and 3:30 p.m. may be used for scouting your pasture or returning to the hunting headquarters area. Hunters will return to headquarters immediately after dark.
7. After a shot is taken, wait a reasonable amount of time before tracking the animal. Do not enter another hunter's area while tracking. Report all shots taken to the ranch personnel. Every effort will be made to retrieve wounded animals but, whether or not found, it will be considered a kill and be applied toward harvest limits.
8. No stalking, night hunting or hunting from vehicles or 4-wheelers. No off-road driving will be allowed – NO exceptions.
9. No hunting is allowed within 50 yards of perimeter fences and electric feeders.
10. No mechanical broad heads, draw lock devices or crossbows may be used.
11. No firearms of any kind allowed on the ranch.
12. No consumption of alcohol is allowed on the ranch except at the end of the day at the ranch headquarters following the return of all hunters back to camp.
13. Smoking in pastures is discouraged due to fire hazards. All cigarettes must be extinguished in a sealed container and disposed of properly.
14. No artifacts, including arrowheads, skulls or shed horns, may be picked up.
15. No littering. All trash, cans, bottles and paper items must be disposed of at the ranch headquarters.
16. All game should be cleaned at ranch headquarters and not in the field.
17. No adjustments are to be made to electric feeders.
18. All corn brought onto ranch must be aflatoxin tested to be less than 20 parts per billion.

Other Considerations

A legal buck deer will have at least 7 measurable points and have an inside spread of at least 14 inches. A measurable point is described as any projection at least 1 inch long measured from the top of the main beam. Any kickers or drops must also be 1 inch long to be considered a point.

A management fee will be charged for any buck killed or wounded that is less than 7 points or has an inside spread of less than 14 inches.

A 50% non-refundable deposit is required to secure a reservation. The remaining balance of your hunt fee will be due upon arrival at the ranch. Payment will be by cash, cashier's check, or money order made payable to Heart-Bar Hunting Services. No personal checks will be accepted at the ranch.

Any violations of State or Federal game laws or the ranch policies will result in loss of hunting privileges without a refund.
